

Good afternoon,

Please see the disaster declaration, fact sheet and press release in English and Spanish for the current presidential declaration in Ohio that was sent to the media. The press release contains the following information:

- SBA Acting Administrator Chris Pilkerton issued the following statement after the announcement of the Presidential disaster declaration for several counties in **Ohio** affected by severe storms, straight-line winds, tornadoes, flooding and landslides on May 27 -29, 2019: “The U.S. Small Business Administration is strongly committed to providing **Ohio** residents with the most effective response possible to assist businesses, homeowners and renters with federal disaster loans. Getting businesses and communities up and running after a disaster is our highest priority.”
- The disaster declaration covers Auglaize, Darke, Greene, Hocking, Mercer, Miami, Montgomery, Muskingum, Perry and Pickaway counties in **Ohio** which are eligible for both Physical and Economic Injury Disaster Loans from the SBA.
- Small businesses and most private nonprofit organizations in the following adjacent counties are eligible to apply only for SBA Economic Injury Disaster Loans: Allen, Athens, Butler, Champaign, Clark, Clinton, Coshocton, Fairfield, Fayette, Franklin, Guernsey, Hardin, Licking, Logan, Madison, Morgan, Noble, Preble, Ross, Shelby, Van Wert, Vinton and Warren in **Ohio**; and Adams, Jay, Randolph and Wayne in **Indiana**.
- SBA will open Business Recovery Centers (BRCs) in Greene and Montgomery County on June 20 to help businesses apply.
- To be considered for all forms of disaster assistance, applicants should register online at DisasterAssistance.gov or download the FEMA mobile app. If online or mobile access is unavailable, applicants should call the FEMA toll-free helpline at 800-621-3362. Those who use 711-Relay or Video Relay Services should call 800-621-3362.

If you are located in a declared disaster area, you may be eligible for financial assistance from the U. S. Small Business Administration (SBA).

What Types of Disaster Loans are Available?

- Business Physical Disaster Loans – Loans to businesses to repair or replace disaster-damaged property owned by the business, including real estate, inventories, supplies, machinery and equipment. Businesses of any size are eligible. Private, non-profit organizations such as charities, churches, private universities, etc., are also eligible.
- Economic Injury Disaster Loans (EIDL) – Working capital loans to help small businesses, small agricultural cooperatives, small businesses engaged in aquaculture, and most private, non-profit organizations of all sizes meet their ordinary and necessary financial obligations that cannot be met as a direct result of the disaster. These loans are intended to assist through the disaster recovery period.
- Home Disaster Loans – Loans to homeowners or renters to repair or replace disaster-damaged real estate and personal property, including automobiles.

What are the Credit Requirements?

- Credit History – Applicants must have a credit history acceptable to SBA.
- Repayment – Applicants must show the ability to repay all loans.
- Collateral – Collateral is required for physical loss loans over \$25,000 and all EIDL loans over \$25,000. SBA takes real estate as collateral when it is available. SBA will not decline a loan for lack of collateral, but requires you to pledge what is available.

What are the Interest Rates?

By law, the interest rates depend on whether each applicant has Credit Available Elsewhere. An applicant does not have Credit Available Elsewhere when SBA determines the applicant does not have sufficient funds or other resources, or the ability to borrow from non-government sources, to provide for its own disaster recovery. An applicant, which SBA determines to have the ability to provide for his or her own recovery is deemed to have Credit Available Elsewhere. Interest rates are fixed for the term of the loan. The interest rates applicable for this disaster are:

What are Loan Terms?

The law authorizes loan terms up to a maximum of 30 years. However, the law restricts businesses with credit available elsewhere to a maximum 7-year term. SBA sets the installment payment amount and corresponding maturity based upon each borrower's ability to repay.

What are the Loan Amount Limits?

- **Business Loans** – The law limits business loans to \$2,000,000 for the repair or replacement of real estate, inventories, machinery, equipment and all other physical losses. Subject to this maximum, loan amounts cannot exceed the verified uninsured disaster loss.
- **Economic Injury Disaster Loans (EIDL)** – The law limits EIDLs to \$2,000,000 for alleviating economic injury caused by the disaster. The actual amount of each loan is limited to the economic injury determined by SBA, less business interruption insurance and other recoveries up to the administrative lending limit. EIDL assistance is available only to entities and their owners who cannot provide for their own recovery from non-government sources, as determined by the U.S. Small Business Administration.
- **Business Loan Ceiling** – The \$2,000,000 statutory limit for business loans applies to the combination of physical, economic injury, mitigation and refinancing, and applies to all disaster loans to a business and its affiliates for each disaster. If a business is a major source of employment, SBA has the authority to waive the \$2,000,000 statutory limit.
- **Home Loans** – SBA regulations limit home loans to \$200,000 for the repair or replacement of real estate and \$40,000 to repair or replace personal property. Subject to these maximums, loan amounts cannot exceed the verified uninsured disaster loss.

What Restrictions are there on Loan Eligibility?

- **Uninsured Losses** – Only uninsured or otherwise uncompensated disaster losses are eligible. Any insurance proceeds which are required to be applied against outstanding mortgages are not available to fund disaster repairs and do not reduce loan eligibility. However, any insurance proceeds voluntarily applied to any outstanding mortgages do reduce loan eligibility.
- **Ineligible Property** – Secondary homes, personal pleasure boats, airplanes, recreational vehicles and similar property are not eligible, unless used for business purposes. Property such as antiques and collections are eligible only to the extent of their functional value. Amounts for landscaping, swimming pools, etc., are limited.
- **Noncompliance** – Applicants who have not complied with the terms of previous SBA loans may not be eligible. This includes borrowers who did not maintain flood and/or hazard insurance on previous SBA loans.

Note: Loan applicants should check with agencies / organizations administering any grant or other assistance program under this declaration to determine how an approval of SBA disaster loan might affect their eligibility.

Is There Help with Funding Mitigation Improvements?

If your loan application is approved, you may be eligible for additional funds to cover the cost of improvements that will protect your property against future damage. Examples of improvements include retaining walls, seawalls, sump pumps, etc. Mitigation loan money would be in addition to the amount of the approved loan, but may not exceed 20 percent of total amount of physical damage to real property, including leasehold improvements, and personal property as verified by SBA to a maximum of \$200,000 for home loans. It is not necessary for the description of improvements and cost estimates to be submitted with the application. SBA approval of the mitigating measures will be required before any loan increase.

Is There Help Available for Refinancing?

- SBA can refinance all or part of prior mortgages that are evidenced by a recorded lien, when the applicant (1) does not have credit available elsewhere, (2) has suffered substantial uncompensated disaster damage (40 percent or more of the value of the property or 50% or more of the value of the structure), and (3) intends to repair the damage.
- Businesses – Business owners may be eligible for the refinancing of existing mortgages or liens on real estate, machinery and equipment, up to the amount of the loan for the repair or replacement of real estate, machinery, and equipment.
- Homes – Homeowners may be eligible for the refinancing of existing liens or mortgages on homes, up to the amount of the loan for real estate repair or replacement.

What if I Decide to Relocate?

You may use your SBA disaster loan to relocate. The amount of the relocation loan depends on whether you relocate voluntarily or involuntarily. If you are interested in relocation, an SBA representative can provide you with more details on your specific situation.

Are There Insurance Requirements for Loans?

To protect each borrower and the Agency, SBA may require you to obtain and maintain appropriate insurance. By law, borrowers whose damaged or collateral property is located in a special flood hazard area must purchase and maintain flood insurance. SBA requires that flood insurance coverage be the lesser of 1) the total of the disaster loan, 2) the insurable value of the property, or 3) the maximum insurance available.

The disaster declaration covers Auglaize, Darke, Greene, Hocking, Mercer, Miami, Montgomery, Muskingum, Perry and Pickaway counties in **Ohio** which are eligible for both Physical and Economic Injury Disaster Loans from the SBA. Small businesses and most private nonprofit organizations in the following adjacent counties are eligible to apply only for SBA Economic Injury Disaster Loans: Allen, Athens, Butler, Champaign, Clark, Clinton, Coshocton, Fairfield, Fayette, Franklin, Guernsey, Hardin, Licking, Logan, Madison, Morgan, Noble, Preble, Ross, Shelby, Van Wert, Vinton and Warren in **Ohio**; and Adams, Jay, Randolph and Wayne in **Indiana**.

SBA will open Business Recovery Centers (BRCs) in Greene and Montgomery County on June 20 to help businesses apply. SBA representatives at the Centers can provide information about disaster loans, answer questions and assist businesses in completing the SBA application. The Centers are located as indicated below and will operate until further notice:

Businesses and private nonprofit organizations of any size may borrow up to \$2 million to repair or replace disaster damaged or destroyed real estate, machinery and equipment, inventory, and other business assets. Applicants may be eligible for a loan increase up to 20 percent of their physical damages, as verified by the SBA for mitigation purposes. Eligible mitigation improvements may

include a safe room or storm shelter, sump pump, French drain or retaining wall to help protect property and occupants from future damage caused by a similar disaster.

For small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations, the SBA offers Economic Injury Disaster Loans to help meet working capital needs caused by the disaster. Economic Injury Disaster Loan assistance is available regardless of whether the business suffered any physical property damage.

Disaster loans up to \$200,000 are available to homeowners to repair or replace disaster damaged or destroyed real estate. Homeowners and renters are eligible up to \$40,000 to repair or replace disaster damaged or destroyed personal property.

Interest rates are as low as **4** percent for businesses, **2.75** percent for nonprofit organizations and **1.938** percent for homeowners and renters with terms up to 30 years. Loan amounts and terms are set by the SBA and are based on each applicant's financial condition.

Applicants may apply online using the Electronic Loan Application (ELA) via the SBA's secure website at DisasterLoan.sba.gov.

To be considered for all forms of disaster assistance, applicants should register online at DisasterAssistance.gov or download the FEMA mobile app. If online or mobile access is unavailable, applicants should call the FEMA toll-free helpline at 800-621-3362. Those who use 711-Relay or Video Relay Services should call 800-621-3362.

The filing deadline to return applications for physical property damage is **Aug. 19, 2019**. The deadline to return economic injury applications is **March 18, 2020**.

Negocios y organizaciones sin fines de lucro de cualquier tamaño pueden tomar prestado hasta \$2 millones para reparar o reponer estructuras destruidas o dañadas, maquinaria, equipo, inventario y otros activos del negocio. Los solicitantes pudieran ser elegibles para un incremento de hasta 20 por ciento del danos físico verificado por SBA para propósitos de mitigación. Mejoras de mitigación elegibles pueden incluir un cuarto de seguridad o refugio de tormentas, sistemas de bombeo, drenaje francés o muros de contención como protección de propiedad y vida de ocupantes para prevenir daños futuros causados por desastres similares.

Para pequeños negocios, pequeñas cooperativas agrícolas, pequeños negocios involucrados en acuicultura y la mayoría de las organizaciones privadas sin fines de lucro, SBA les ofrece préstamos para Daños Económicos que le ayuden a cubrir las necesidades de capital de trabajo causadas por el desastre. Asistencia Económica por desastres está disponible sin importar si el negocio sufrió pérdidas por danos físicos.

Préstamos de Desastres hasta \$200,000 están disponibles para dueños de Hogares para reparar o reponer estructuras destruidas o dañadas. Dueños de hogares e inquilinos son elegibles para préstamos de hasta \$40,000 para reparar o reponer propiedad personal destruida o dañada.

Las tasas de interés son tan bajas como **4** por ciento para negocios, **2.75** por ciento para organizaciones sin fines de lucro y **1.938** por ciento para dueños de hogares e inquilinos con términos de hasta 30 años. Las cantidades de los préstamos son determinadas por SBA a base de la condición financiera de cada solicitante.

Los solicitantes pueden solicitar en línea utilizando la Solicitud Electrónica de Préstamo (ELA por sus siglas en inglés) mediante el portal seguro de SBA en DisasterLoan.sba.gov.

Para ser considerados para toda forma de asistencia por desastres, los solicitantes deberán de registrarse en línea a DisasterAssistance.gov o bajar la aplicación móvil de FEMA. Retirement Security and Savings Act

Recently, Ohio Senator Rob Portman and Maryland Senator Ben Cardin reintroduced the bipartisan Retirement Security and Savings Act in the U.S. Senate. This legislation addresses multiple challenges within the retirement saving system, with the goal of making it easier for people to save for a secure retirement.

Some of the issues the bill addresses include improvements to the Saver's Tax Credit, eventually increasing the age for Required Minimum Distributions (RMDs) for accounts with less than \$100,000 and reducing the penalty for non-compliance with RMDs.

The ultimate goal of the Senators is to help Americans, specifically the aging population with little to no retirement savings, people with low incomes or those with inadequate retirement savings.
